SECTION 2: Hazard identification

General hazard statement

Description of necessary first-aid measures

General advice First Aid Facilities: Maintain eyewash fountain in work area.

SECTION 5: Fire-fighting measures

Suitable extinguishing media

Specific Methods: Small fire: Use dry chemical, CO2, water spray or foam.

Large fire: Use water spray, fog or foam.

If safe to do so, move undamaged containers from the fire area. Cool containers with flooding quantities of water until well after the fire is out.

Specific hazards arising from the chemical

Carbon monoxide, carbon dioxide, irritating and toxic fumes and gases, sulfur oxides, and compounds of nitrogen.

Material does not burn. Runoff may pollute waterways. Fire or heat may produce irritating, poisonous and/or corrosive fumes. Containers may explode when heated.

Special protective actions for fire-fighters

Fire fighters should wear full protective clothing and self-contained breathing apparatus (SCBA) operated in positive pressure mode. Fight fire from safe location.

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures

Ensure adequate ventilation. Use personal protective equipment. Avoid dust formation. For personal protection see section 8.

Methods and materials for containment and cleaning up

Ventilate area of leak or spill. Sweep up and containerize spills for reclamation or disposal. Vacuuming or wet sweeping may be used to avoid dust dispersal.

SECTION 7: Handling and storage

Precautions for safe handling

Protect against physical damage. Keep away from heat and all sources of ignition. Use with adequate ventilation. Minimize dust generation and accumulation. Avoid ingestion and inhalation. Avoid contact with eyes, skin, and clothing. Avoid prolonged or repeated exposure. Wash thoroughly after handling. Wash clothing before reuse.

Conditions for safe storage, including any incompatibilities

Store in tightly closed, sealed containers in a cool, dry, well-ventilated place away from incompatible materials. Keep from contact with oxidizing materials. Protect from humidity and keep away from water. Protect against physical damage. Keep well protected from direct sunlight and moisture. Once prepared, stack agar plates upside down in the refrigerator.

Storage Temperatures: Store at 2 - 30 °C.

Appropriate engineering controls

Use ventilation adequate to keep exposures (airborne levels of dust, fume, vapor, gas, etc.) below recommended exposure limits.

Eye/face protection

The use of a face shield, chemical goggles or safety glasses with side shield protection as appropriate. Must comply with Australian Standards AS 1337 and be selected and used in accordance with AS 1336.

Skin protection

Clean impervious clothing should be worn. Clothing for protection against chemicals should comply with AS 3765 Clothing for Protection Against Hazardous Chemicals.

Suitable protective workwear, e.g. cotton overalls buttoned at neck and wrist is recommended. Chemical resistant apron is recommended where large quantities are handled.

Respiratory protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable vapor/ mist filter should be used. Refer to relevant regulations for further information concerning respiratory protective requirements. Reference should be

made to Australian Standards AS/ NZS 1715, Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716, Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.
