### 4. First-aid measures

**Inhalation** If inhaled, remove from contaminated area to fresh air immediately. Apply artificial respiration if not breathing. If breathing is difficult, give oxygen. Immediately obtain medical aid if cough or other symptoms appear.

### 5. Fire-fighting measures

<b>Other Exposure Information</b>	<p>These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.</p> <p>A time weighted average (TWA) has been established for Nitric acid 4ppm (Safe Work Australia) of 10 mg/m<sup>3</sup>. The corresponding STEL (Short Term Exposure Limit) is 2 ppm or 5.2 mg/m<sup>3</sup>. The STEL is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The exposure value at the TWA is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week.</p>
