SECTION 4: First-aid measures

Description of necessary first-aid measures

General advice	First Aid Facilities: Maintain eyewash fountain and drench facilities in work area.
If inhaled	If inhaled, remove from contaminated area to fresh air immediately. Apply artificial respiration if not breathing. If breathing is difficult, give oxygen. Get medical aid if cough or other symptoms appear.

SECTION 5: Fire-fighting measures

Suitable extinguishing media

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

SECTION 7: Handling and storage

Precautions for safe handling

Avoid ingestion and inhalation of vapours, or dust. Avoid contact with eyes, skin, and clothing. Avoid prolonged or repeated exposure. Minimize dust generation and accumulation. Keep container locked up and tightly closed. Ensure good ventilation at the workplace. Use with adequate ventilation. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately and show the container or the label. Wear suitable protective clothing. Wash thoroughly after handling. Remove contaminated clothing and wash before reuse. Protect against physical damage. Keep away from incompatibles such as oxidizing agents.

Store in a well-ventilated place. Keep container tightly closed. Store in a cool place.

Appropriate engineering controls

Eye/face protection

The use of a face shield, chemical goggles or safety glasses with side shield protection as appropriate. Must comply with Australian Standards AS 1337 and be selected and used in accordance with AS 1336.

Clean impervious clothing should be worn. Clothing for protection against chemicals should comply with AS 3765 Clothing for Protection Against Hazardous Chemicals.

Hand Protection: Ensure hand protection complies with AS 2161, Occupational protective gloves - Selection, use and maintenance.

Body protection

Suitable protective workwear, e.g. cotton overalls buttoned at neck and wrist is recommended. Chemical resistant apron is recommended where large quantities are handled.

Respiratory protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable vapor/ mist filter should be used. Refer to relevant regulations for further information concerning respiratory protective requirements. Reference should be made to Australian Standards AS/ NZS 1715, Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716, Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.
